Bradford County Conservation District: Working for You

The Bradford County Conservation District was created through a resolution of the Board of County Commissioners on November 13, 1956, under the authority of P.L. 547 of 1945. Conservation Districts exist in virtually every county across the country. Created in the 1940's and 50's their purpose is to provide the landowners and managers of each county's natural resources a voice in identifying management needs. Assisting in developing strategies to meet those needs and provide them the authority to enter into agreements to implement the strategies.

In Pennsylvania Conservation Districts are governed by a board of directors that represents the land uses in the county. The seven board members in Bradford County are made up of four members from the agricultural community, two from a non-farm background, and one County Commissioner. The board members are appointed to the board by the County Commissioners from a list of nominees provided by approved county-wide representative organizations. They serve for three year terms with the

exception of the commissioner who is appointed annually. The base of much of what the Conservation District is able to accomplish is its working agreements with various federal, state, regional and local partners. These agreements, often called "memorandums of understanding", outline what type of services and programs are available to people in the county and what the

conditions are for securing those services. A big role of the Conservation District is connecting individuals and organizations to those services. Over the years the Conservation District has developed the expertise and working relationships with their partners that have led to contracts that empower the District to administer cost share programs, technical programs, educational, informational and certification

programs. Since each Conservation District is administered locally, even though they share the same mission, they all differ in their approach, scope and expertise. In Bradford County, the District employs 15 professionals. They are configured into several teams which include: Administrative, Agricultural, Technical and Educational. Being locally administered, the District has the flexibility to set priorities on programming and services. It is extremely useful with the Natural Gas educational programs that the District provides. They include a full array of planning, technical, design, informational and educational

County Level Natural Gas Forum held in Sayre



County Level Leaders meet in Sayre to discuss the role of task forces and committees

On March 30, 2010 the Bradford County Gas Advisory Board hosted a meeting at the Sayre Best Western for several task force groups. It was the first meeting of its kind that brought county level leaders together to exchange and share ideas with nearly 100 people in attendance. Presentations were given by various task force groups. They included Bradford County, Tioga County, NY, and Lycoming County. The meeting was planned by members of the

Bradford County Natural Gas Advisory Committee, Mark Madden, Mike Lovegreen, Mark Smith and Stacey Bellows. It was the hope of the committee to share information and learn from each others experiences. Several of those dealing with natural gas development in their regions had the opportunity to present a short program about their experiences. Kathy Brasier, professor of Rural Sociology at Penn State University, spoke about the role that a county task force can have, the importance of setting goals for the task force, the purpose of the task force and the ability to judge the effectiveness of the task force. She informed the group ways to improve existing task forces and how important it is to organize and establish priorities. Mark Madden said "Everyone involved had a chance to take something

useful from the forum. We identified several areas where fact-sheets could help guide land-owners, task force members and/or other stakeholders in this process." Bradford County presented facts about the gas drilling operations in Bradford County and how the committee worked. Smith stated "We have a good committee but we learned a lot of things at the meeting on how to improve what we have." Originators of this event were happy with the numbers who attended and appreciated the exchange of information between the task force groups.

TING-(Tioga Investigates Natural Gas) was formed in 2009 and was initiated by the county Ag Resources office. They spoke about their identification and prioritizing impacts to the county and their mission of addresses public sector impacts and opportunities of natural gas drilling in

Tioga County.

Mike Lovegreen said "I was very happy with the outcome of the meeting, and have received several emails from people who attended who felt it was very informative and well done." Attendees at the event felt it was important to hold this sort of meeting on a regular basis.

“Old Barclay” : Presentation at Bradford County Library

"Old Barclay: A History of Coal Mining on Barclay Mountain," will be presented on Tuesday, April 6, 7 p.m. at the Bradford County Library. Matthew Carl, Managing Curator of the Bradford County Historical Society will do the presentation. "Old Barclay: A History of Coal Mining on Barclay Mountain" reviews the story of Barclay Mountain's coal mining settlements which include Barclay, Fall Creek, Dublin, Graydon, Foot of Plane, Carbon Run, and Long Valley. The old methods of

coal mining are described and the development of the incline plane, railroad, and canal system will also be discussed.

A native of Bradford County, Matthew Carl, became interested in the history of his community at the age of 10. It was at that time that he first visited Laquin, the site of a former lumber town on Barclay Mountain. His interest in the topic grew throughout high school, resulting in local history projects both in school and as a hobby. Today
