

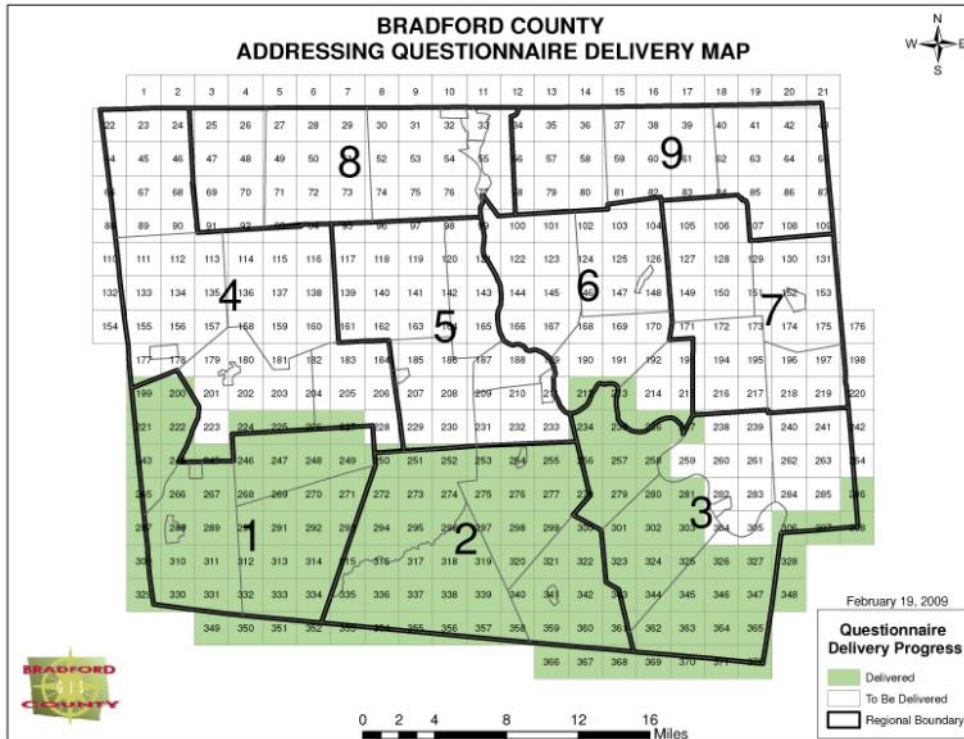

The project is currently in the questionnaire delivery stage. At this stage of the project each resident should receive a questionnaire at their residence. Once the questionnaire is received we ask that you complete and return the postage paid questionnaire within the 30 days requested.

**Questionnaire Delivery**

November '08 - February '08. Delivery of questionnaires in regions 1-3

March '09 - July '09. Delivery of questionnaires in regions 4, 5, 6, 7 .

August '09 - September '09. Delivery of questionnaires in regions 8 - 9

**Final Address Delivery**

August '09 - September '09. Delivery of final address in regions 1-3

December '09 - January '10. Delivery of final address in regions 4, 5, 6, 7

February '10 - March '10. Delivery of final address in regions 8 - 9 .

# Inside the Increased Inmate Work Opportunities at the Bradford County Correctional Facility

## Print Shop

For over 30 years the Bradford County Print Shop has been a valuable asset to the employee's of the county. It was originally a part of the election office but was later moved to its own office in the courthouse where it supplied letterhead, envelopes, forms and any other printed materials for county offices. During the time that Interim Warden Gavin was here it was suggested the Commissioners move the Printshop to the Bradford County Correctional Facility. This would provide an opportunity to utilize inmate labor to offset county workforce costs, while at the same time giving the inmate a chance to learn skills which

they can use after their release. Kevin Prickett, Counselor at the Bradford County Correctional Facility has been assigned the duty of training the inmates and is presently working on getting them NOCTI (National Occupational Competency Testing Institute) certified. Deputy Warden, Pete Quatrini and Kevin Prickett, have toured the print shop at the Waymart Correctional Facility to gain knowledge of running this kind of operation in a jail. All orders are done electronically. Inventory is recorded on the computer and shared between the courthouse and the jail. Bradford County Correctional Facility will continue to look for opportunities to further the services of the print shop for the county.

## Laundry

To cut labor cost at the Bradford County Manor the linen service laundry was moved from the Bradford County Manor to the Bradford County Correctional Facility on January 9, 2009. The manor residents

personal laundry will still be done at the manor but all the linen service, such as sheets, pillow cases, and blankets will be done at the jail. The washer and dryer were moved from the manor to the jail and a new schedule was

implemented at the jail to provide for 2 shifts of inmates. There are 3 inmates on each shift. At 10:00 p.m. every evening the staff from the jail go to the manor and pick up the laundry. After the laundry is brought back to the jail the inmates

begin the process of washing, drying and folding the laundry. The first shift of inmates begins at 12:00 a.m. and the second shift ends about 10:00 a.m. the next day. They process about 5-6 carts of laundry per night. Probably the biggest challenge faced by the jail was the logistics of getting the laundry back and forth and working out the details of times and transportation. It has been fully operational for over a month now and everything seems to be going smoothly. The manor predicts that this move will save them approximately \$100,000 for the year.

## Town Hall Meeting on Underage Drinking

The Bradford County Communities that Care and the Bradford/Sullivan County Alcohol, Tobacco and Other Drugs Coalition hosted a town hall meeting at the First Baptist Church in Troy on February 5, 2009. Community members were invited to attend to learn facts about underage drinking and to take part in a “café” style discussion.

Underage drinking is a growing concern on the part of many community members. It isn't just a problem here in Bradford County but across the nation. The Surgeon General put out a call to action last year to decrease underage drinking; he asked that everyone in the community to get involved.

As a result town hall meetings have been held in Towanda, and Sayre. It was decided to try a different type of town hall meeting this year which provided an opportunity for participants to share their thoughts on underage drinking, where youth are accessing alcohol and how to change the attitudes of adults and youth alike.

The town hall meeting was started with a panel discussion which included Tom Carman, Bradford County Coroner; Troy Police Chief Kyle

Wisel, Tom Brandt, Trauma Program Manager of Robert Packer Hospital Regional Trauma Center. Troy Police Officer Floyd McDonald accompanied Chief Wisel. The panel had a lot of information to provide; including statistics. Tom Carman reported that in 2008 there were 8 deaths of youth that were connected to alcohol in 2008. Tom Brandt reported that 60% of the people 20 years and under who came into the trauma unit had alcohol in their system. As the evening proceeded participants were asked to take places at tables that had been arranged in a “café style” atmosphere to provide them the opportunity to voice their thoughts and ideas.

They were asked three questions regarding underage drinking. The first question was “What are our thoughts on underage drinking? They were given fifteen minutes to discussion and write their thoughts down. Some of the comments were: “A mess”, “rampant”, “socially acceptable”. The participants were then asked to move two more times during the evening to a new table with new people to discuss the other two questions. “Where are young people getting the alcohol”. Some answers that were given were “Friends”,

“Family”, and “Maybe buying it”.

The last question of the evening was, “How do you think underage drinking can be addressed and what are the resources that we will be needed to accomplish this? Many comments were made including, “Education in preschool (starting early), “speaking up – don't be afraid to speak up”, “People are fearful of speaking up because of repercussions and consequences.”

Both members of Communi-

ties That Care and community participants had a lot to say and lively discussions were held. At the end of the evening a “harvest” was held to bring everyone's ideas together. Some of the ideas from this “harvest” were “Social Norming” “Building leadership skills”, “Empower parents”, and “Positive role models”. The CTC members will take back to their coalition the information that was gained with the purpose of developing a plan on ways to address underage drinking.
