WARNING ABOUT YOUR LEGAL RIGHTS

Self-represented litigants are held to the same standards as attorneys admitted to the bar of the Commonwealth of Pennsylvania. Representing yourself does not exempt you from understanding and following statewide and local Rules of Court. This packet is NOT intended to provide you with legal advice.

- 2. Petition for Modification of a Custody Order and a Proposed Order of Court (for scheduling of preliminary custody conference)
 - 3. 2 copies of Criminal Record/Abuse History Verification form

 - 5. Education Program for Separated Parents Registration Form
 - 6. Entry of Appearance as Self-Represented Party Form
 - 7. Divorce/Custody Cover Sheet

Instructions:

- 1. Read and complete the attached Confidential Information Form and Confidential Document Form. You are responsible for protecting your private information and the information pertaining to your child(ren). Visit *Pacourt.us/learn/representing-yourself* to read How to File Confidential Information and Documents with the Court.
- 2. Read and complete the Petition for Modification of a Custody Order. You are the Petitioner. All information must be filled in. A copy of the most recent Order (the Order you are requesting be modified) **must** be attached.
- 3. Read and complete one copy of the Criminal Record/Abuse History Verification form with regard to yourself and anyone in your household. Leave the other copy blank.
- 4. Complete the Entry of Appearance as Self-Represented Party form

- 5. If you do not think you can pay the filing fee, you can ask the Court to waive the costs. The form you need to fill out is the Petition for In Forma Pauperis, which can be printed from the Court's web site (http://bradfordcountypa.org/courts-administration/ in the "Other Forms" folder) or a copy obtained from Court Administration. The Court will review this Petition for In Forma Pauperis and decide whether or not you meet the financial requirements to waive the filing fee for Petition to Modify Custody. If you can pay the filing fee, the Petition for In Forma Pauperis does not need to be completed or filed.
- 6. Complete the Divorce/Custody Cover Sheet
- 7. Take the following completed forms
 - (1.) Completed Confidential Information Form and Confidential Document Form
 - (2.) Completed Petition for Modification of Custody Order
 - (3.) Proposed Order of Court
 - (4.) 1 completed copy of Criminal Record/Abuse History Verification form
 - (5.) Completed Entry of Appearance as Self-Represented Party form
 - (6.) Divorce/Custody Cover Sheet
 - (7.) If applicable, Completed In Forma Pauperis Petition

PLUS 2 copies of each AND a large self-addressed stamped envelope to the Prothonotary's Office, located on the second floor of the Bradford County Court House, 301 Main Street, Towanda, Pennsylvania. Be certain that your self-addressed stamped envelope is large enough and contains sufficient postage to mail two (2) copies of the forms to you.

- 8. Once the forms are reviewed and dates are scheduled by the Court officials, they will be returned to the Prothonotary. The two (2) copies with the scheduled dates will be returned to you in the self-addressed stamped envelope that you provided. If you do not receive two (2) copies within two (2) weeks of filing, it is YOUR responsibility to contact the Prothonotary's Office and/or Court Administration to determine the status of your documents.
- 9. Once your two (2) copies are returned to you, YOUR ARE RESPOSIBLE for Service of one (1) copy each of Petition to Modify Custody, Order scheduling the preliminary custody conference, your completed Criminal Record/Abuse History Verification, the blank Criminal Record/abuse History Verification, Entry of Appearance form, and In Forma Pauperis Petition and Order (if applicable). Service means providing a copy to the opposing party pursuant to Pa. Rules of Civil Procedure, which does include certified mail, return receipt requested to be signed by the addressee only.

DO NOT personally deliver the forms to the opposing party yourself as this is not proper service. You may have the Sheriff Office serve the documents. There will be charge for the Sheriff's service, unless your costs have been waived.

10. After service is complete, you must complete the Proof of Service form and file it with the Prothonotary's Office or bring it to the preliminary custody conference.

- Complete Confidential Information Form and Confidential Document Form
- Complete Petition to Modification of a Custody Order and attach a copy of most recent Order for Custody

- o Make 2 copies of all the original forms you completed?
- o Prepare one (1) large self-addressed and stamped envelope?

Upon your receipt of the 2 copies from the Prothonotary's Office: DID YOU...

- Serve the opposing party a copy of the Petition for Modification of Custody, the Order scheduling the preliminary custody conference, your completed Criminal Record/Abuse History Verification form, the blank Criminal Record/Abuse History Verification form, Entry of Appearance form, and In Forma Pauperis Petition and Order (if applicable)
- Complete the Proof of Service form and file with Prothonotary or plan to take with you to the Preliminary Custody Conference?

Instructions for Completing the Confidential Information Form

The following information is confidential and shall not be included in any document filed with a court or custodian, except on a Confidential Information Form filed contemporaneously with the document:

- 1. Social Security Numbers
- Financial Account Numbers, except an active financial account number may be identified by the last four digits when the financial account is the subject of the case and cannot otherwise be identified. "Financial Account Numbers" include financial institution account numbers, debit and credit card numbers, and methods of authentication used to secure accounts such as personal identification numbers, user names and passwords.
- 3. Driver License Numbers
- 4. State Identification (SID) Numbers
- 5. Minors' names and dates of birth except when a minor is charged as a defendant in a criminal matter (see 42 Pa.C.S. § 6355). "Minor" is a person under the age of eighteen.
- 6. Abuse victim's address and other contact information, including employer's name, address and work schedule, in family court actions as defined by Pa.R.C.P. No. 1931(a), except for victim's name. "Abuse Victim" is a person for whom a protection order has been granted by a court pursuant to Pa.R.C.P. No. 1901 et seq. and 23 Pa.C.S. § 6101 et seq. or Pa.R.C.P. No. 1951 et seq. and 42 Pa.C.S § 62A01 et seq. If necessary, this information must be provided on the separate Abuse Victim Addendum. Please note there are separate instructions for the completion of the Addendum located on the form.

Please note this form does not need to be filed in types of cases that are sealed or exempted from public access pursuant to applicable authority (e.g. juvenile, adoption, etc.).

- The best way to protect confidential information is not to provide it to the court. Therefore, only provide confidential information to the court when it is required by law, ordered by the court or is otherwise necessary to effect the disposition of a matter.
- Do not include confidential information in any other document filed with the court under this docket.
- If you need to refer to a piece of confidential information in a document, use the alternate references. If you need to attach additional pages, sequentially number each alternate reference i.e. SSN 3, SSN 4, etc.
- This form, and any additional pages, must be served on all unrepresented parties and counsel of record.

A court or custodian is not required to review or redact any filed document for compliance with Public Access Policy of the Unified Judicial System of Pennsylvania. Case Records of the Appellate and Trial Courts. A party's or attorney's failure to comply with this section shall not affect access to case records that are otherwise accessible.

If a filed document fails to comply with the requirements of the above referenced policy, a court may, upon motion or its own initiative, with or without a hearing, order the filed document sealed, redacted, amended or any combination thereof. A court may impose sanctions, including costs necessary to prepare a compliant document for filing in accordance with applicable authority.

Abuse Victim Addendum

Instructions for Completing the Abuse Victim Addendum: The Abuse Victim Addendum shall accompany a filing where confidential information is being provided by an abuse victim, as defined in this policy, in family court actions (see Pa.R.C.P. No. 1931(a)), as required by law, ordered by the court, or otherwise necessary to effect the disposition of a matter. This addendum, and any additional pages, shall only be provided to the court and shall remain confidential. The best way to protect confidential information is not to provide it to the court. Therefore, only provide confidential information to the court when it is required by law, ordered by the court or is otherwise necessary to effect the disposition of a matter.
