Three deaths in one weekend. Our community is still in shock and mourning. There were multiple opiate related overdoses and deaths in our county before that horrific weekend and many more are sure to follow if we don't act decisively. We have spoken with close to one thousand county residents in the month since Ben's death and one thing is clear. The citizens of Bradford County have had enough. We have got to do something in response to this epidemic of drug use and overdose in our county.

This rally will be a step in the right direction. It promises to be an evening filled with powerful speakers, local agencies that offer help, music, food, fellowship, and a candlelight vigil. Let's get together. Let's trade ideas. Let's ask some tough questions and perhaps we will come up with some genuine solutions. We hope and pray that this rally will be historic both in content and attendance. If we stand together in love, solidarity, and thoughtful strategy we can stem the tide of this destructive, heart wrenching, and deadly epidemic.
