UNFINISHED BUSINESS

A motion was made by Mr. Miller, seconded by Mr. McLinko, all voted “aye” to approve the minutes of Thursday, March 9, 2017.

A motion was made by Mr. Miller, seconded by Mr. McLinko, all voted “aye” to award the Housing Rehab Inspector contract to JMSI Environmental Corp., the lowest responsible bidder.

A motion was made by Mr. Miller, seconded by Mr. McLinko, all voted “aye” to approve the renewal of an Agreement between Bradford County and Ron and Cindy Chaapel as seasonal Sunfish Pond Park Concessionaires for a period of one year (April 1, 2017 through March 31, 2018).

Jennings, Esquire for the provision of legal services to clients on behalf of the Bradford County Public Defender's office for a term of 12 months (January 1, 2017 – December 31, 2017) at a rate of \$40.00 per hour, not to exceed a total of fifteen hours per week.




