

- Q. What is the "Education Program for Separated Parents?"
- A. This is a 4-hour class designed to help parents focus on what kids go through when their parents divorce or separate.
- Q. What is the purpose of this program?
- A. The purpose of the program is to reduce the stress of divorce and parental separations for children.
- Q. Who attends the program?
- A. The Court requires all parents with children under 18 who seek a divorce or custody change to attend the program. The Court may order parties in other domestic actions to attend.
- Q. Is this divorce counseling?
- A. No, this is an educational program for a large group. It is not necessary to speak.
- Q. When is the program?
- A. The program is presented on one Saturday every other month from 8:30 a.m. to 12:30 p.m.

- Q. Where is the program held?
- A. At the Bradford County Courthouse, Towarda, PA in Court Room No. 2.
- Q. How do I register?
- A. Detach the Registration form and send as soon as possible with your payment (CHECK OR MONEY ORDER, ONLY!) to the address on the form or stop by the Court Administrator's Office at the Courthouse.

 You CANNOT register by phone.
- Q. What is the cost to attend?
- A. The fee is \$35.00 per person and both parents (and grandparents, if involved in the case) are required to attend. The fee may be waived or reduced by the court administrator in consultation with the court.
- Q. What if I feel unsafe attending the same program as the other parent?
- A. There will be a deputy sheriff present at each program to assure your safety. If you have concerns, please inform the deputy.
