Consider ratifying action taken on February 23, 2015 authorizing the Chief Clerk to legally advertise the following:

We do also notify you, in accordance with Section 905 of the Pennsylvania Election Code, that the offices for which candidates are to be nominated at the Municipal Primary Election, May 19, 2015, and elected to office at the Municipal Election, November 5, 2015 and for which offices, nomination petitions must be filed in the office of the Secretary of the Commonwealth, and the number to be elected are as follows:

<u>Judicial Offices to be elected:</u> Judge of the PA Superior Court, Judge of Commonwealth Court

<u>County Offices to be elected:</u> Auditors, Commissioners, Sheriff, Prothonotary/Clerk of Courts, Register of Wills & Recorder of Deeds, District Attorney, Treasurer, Coroner

<u>Local Offices to be elected:</u> Supervisors, Councilmen, Auditors, Tax Collectors, School Directors

A motion was made by Mr. McNett, seconded by Mr. Tubbs, all voted "aye" to approve the placement of the following question on the ballot for Northeast Bradford School District in the General Primary Election on May 19, 2015.

We hereby certify that the following is a true and correct statement of the Referendum filed for the Northeast Bradford School District in Bradford County:

Optional Occupation Tax Elimination Act Referendum Northeast Bradford School District: Do you favor eliminating the school district Occupation Tax with revenue produced by increasing the rate of the Earned Income Tax to a maximum of .93%?

Explanation of Ballot Question Northeast Bradford School District

The Northeast Bradford School District has caused a referendum to be placed on the ballot concerning certain tax reform authorized by Act 24 of 2001. If approved by a majority of the voters, this referendum would allow increasing the rate of the Earned Income Tax to a maximum of .93% with the increase in revenues being used to eliminate the Occupation Tax currently levied.

The current rate for Earned Income Tax is .5%. The maximum allowable rate for the Earned Income Tax if the referendum is approved pursuant to Act 24 of 2001 is .93%

If a majority of the electors voting on the question vote "Yes," then the School District will be authorized to eliminate the Occupation Tax and increase the Earned Income Tax effective July 1, 2016. If a majority of the electors voting on the question vote "No," the School District shall have no authority to increase the rate of the Earned Income Tax above the Maximum rate otherwise provided by law.

Voters' approval of the referendum will not reduce or eliminate any real estate taxes but will eliminate the \$5.00 per capita tax.
