NATIONAL ADULT BASIC EDUCATION AND FAMILY LITERACY WEEK SEPTEMBER 24 – 30, 2017

WHEREAS, more than 30 million people in the United States cannot read, write, or do basic math above a third grade level; and

WHEREAS, American employers spend more than 125.9 billion each year on training, including remedial reading, writing, and math skills, and the literacy of its citizens is essential for the economic well-being of the United States; and

WHEREAS, each high school dropout costs the United States economy approximately \$260,000 in lost earnings, taxes, and productivity over his/her lifetime, the percentage of students with less than a 12th grade education have decreased from 70% in 2010-2011 to 59% in 2015-2016 because of enrollment in an Adult Literacy Program; and

WHEREAS, a mother's level of reading skill is the greatest determinant of her child's academic success, and children of parents who had not completed high school scored lower in vocabulary assessments, the education level of parents has a direct impact on the educational success of their children; and

WHEREAS, adults with low health literacy are less likely to get flu shots, delay or forgo mammograms, and more likely to suffer from heart failure, therefore endangering their lives and the lives of their loved ones; and

WHEREAS, 1.5 million people with the lowest levels of literacy are incarcerated, raising high school graduation rates would significantly decrease incarceration rates and reduce costs associated with crimes; and

WHEREAS, the National Adult Education and Family Literacy Week highlights the need for the nation to support efforts to ensure each and every person has the necessary literacy skills to succeed at home, at work, and in society.
