ASK A POLL WORKER FOR A NEW BALLOT.

To enter a STRAIGHT PARTY vote, completely blacken the square to the left of the name of that party. Selecting a party automatically selects all candidates associated with that party. If you select a candidate associated with a party other than the straight party selection, the straight party vote will no longer apply for that contest.
