**PROPOSED CONSTITUTIONAL AMENDMENT 1  
TERMINATION OR EXTENSION OF DISASTER  
EMERGENCY DECLARATIONS**

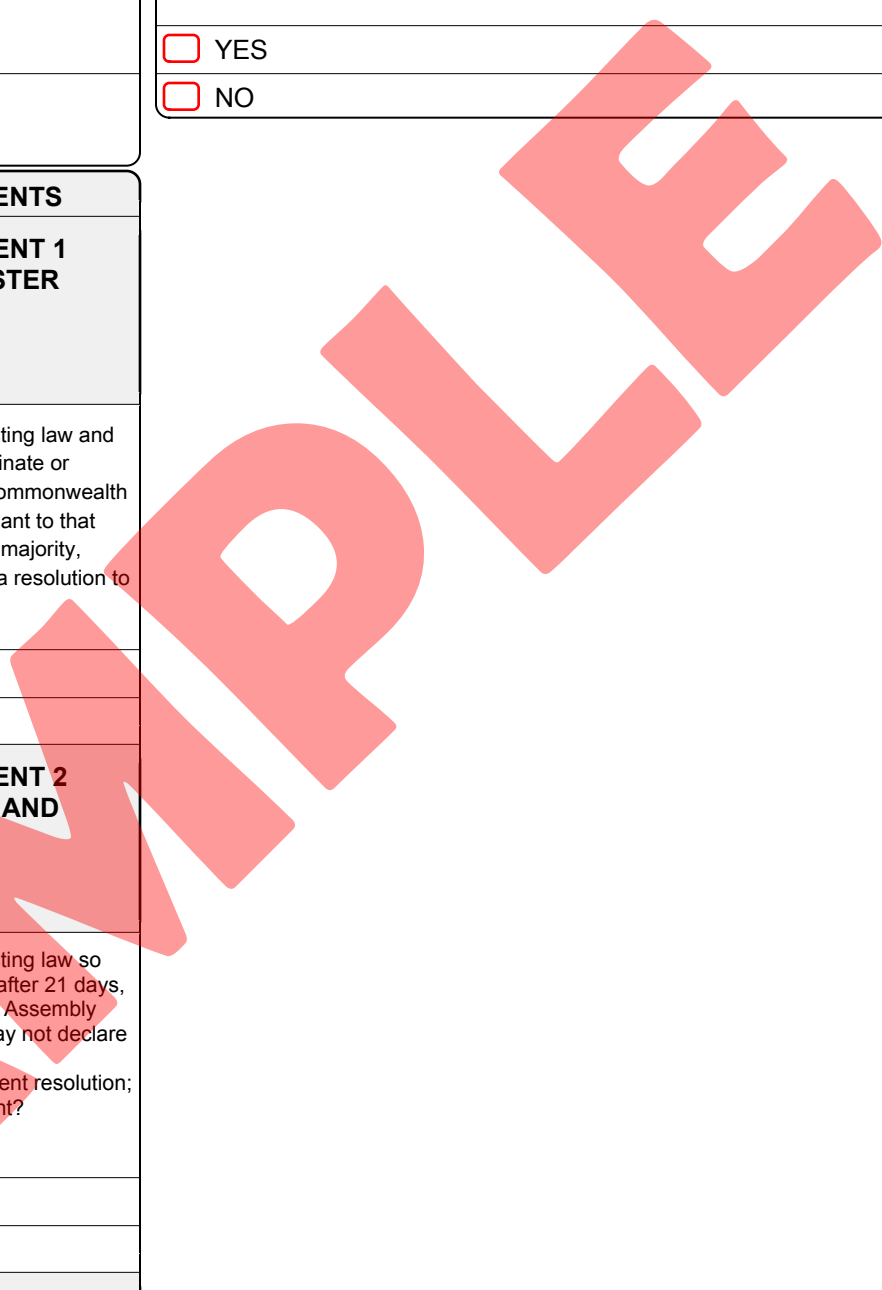
