TERMINATION OR EXTENSION OF DISASTER
EMERGENCY DECLARATIONS**

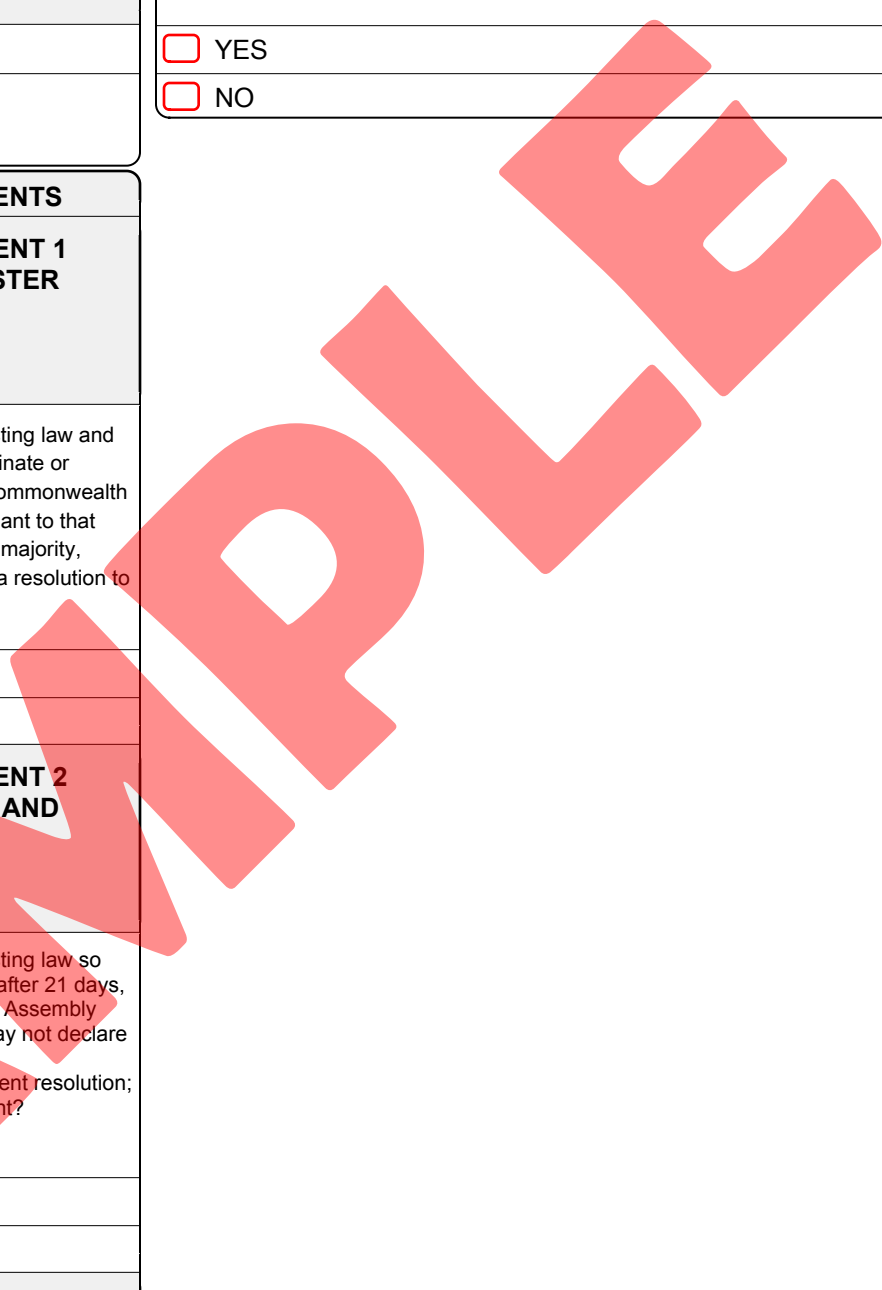
