Pursuant to the Pennsylvania Election Code, Section 3031.14, the Bradford County Board of Elections will conduct pre-election testing of the Electronic Tabulating Equipment to ascertain the accuracy of the central count equipment for all votes cast for all offices in the November 2, 2021 Municipal Election.

A pre-election testing will take place in the Election Office, Bradford County Court House Annex, 6 Court St., Suite 2, Towanda, on Thursday, October 28, 2021 at 11:30 a.m.

Consider authorizing the Chief Clerk to legally advertise the following:

The Bradford County Return Board will meet in the office of the Election Department of Bradford County, Court House, Towanda, Pennsylvania at 7:00 a.m. on Tuesday, November 2, 2021 and continue throughout the week as necessary, for the purpose of computing and canvassing returns of votes cast at the Municipal Election of November 2, 2021.

The Bradford County Board of Election will meet Thursday, November 4, 2021 at 11:00 a.m. in the office of the Commissioner's Conference Room to determine the eligibility of any and all provisional ballots cast in the November 2, 2021 Municipal Election to be included and counted in the official canvass.

Voters who have cast a Mail-In or an Absentee Ballot and have not supplied a valid form of ID for Municipal Election to be held on November 2, 2021, have until the sixth calendar day after the Municipal Election to provide their ID to the Bradford County Board of Election, in order for their ballot to be counted.

Consider authorizing the Chief Clerk to legally advertise the polling locations and times for the Municipal Election on November 2, 2021.

In accordance with Section 905 of the Pennsylvania Election Code that the offices for which candidates are to be nominated at the Municipal Election on November 2, 2021 between the hours of 7:00 a.m. and 8:00 p.m. prevailing time and for which offices, nomination petitions must be filed in the office of the Secretary of the Commonwealth and the number to be elected are as follows:

- One Justice of the Supreme Court
- One Judge of the Superior Court
- Two Judge of the Commonwealth Court
- One Coroner (Two Year Term)
- One District Attorney (Two Year Term)

Local Municipalities- Supervisors, Auditors, Council, Tax Collectors, Mayor and School Directors, Judge of Elections, Inspector of Elections and Constables.
