WHEREAS	they save an average of \$6000 for every individual they serve; and
WHEREAS	treatment court significantly improves substance use disorder treatment outcomes, substantially reduce addiction and related crime, and do so at less expense than any other criminal justice strategy; and
WHEREAS	treatment courts improve education, employment, housing and financial stability, promote family reunification, reduce foster care placements, and increase the rate of addicted mothers delivering babies who are fully drug free; and
WHEREAS	treatment courts facilitate community-wide partnerships, bringing together public safety and public health professionals; and

WHEREAS treatment courts demonstrate that when one person rises out of substance use and crime, we all rise.

THEREFORE, we, the Bradford County Commissioners, by virtue of the authority vested in us by the Constitution and laws of Pennsylvania do hereby proclaim May 2024 as "Drug Court Awareness Month".

#### A PROCLAMATION IN HONOR OF APRAXIA AWARENESS DAY

WHEREAS, May 14, 2024, marks Childhood Apraxia of Speech Day during which awareness will be raised throughout Pennsylvania about childhood apraxia of speech, an extremely challenging speech disorder that affects 1-in-1,000 children.

WHEREAS, Childhood Apraxia of Speech (CAS) causes children to have significant difficulty learning to speak and is among the most severe speech deficits in children

WHEREAS, the act of learning to speak comes effortlessly to most children, those with apraxia require early, appropriate, and intensive speech therapy, often for many years to learn to speak.

WHEREAS, without appropriate speech therapy intervention, children with apraxia will have diminished communication skills, but are also placed at high risk for secondary impacts in reading, writing, spelling, and other school related skills. WHEREAS that such primary and secondary impacts diminish future independence and employment opportunities and challenge the ability to become productive, contributing citizens if not resolved or improved.

WHEREAS, public awareness about Childhood Apraxia of Speech in Pennsylvania is essential for families of children with this neurological disorder and the professionals who support them to achieve the needed services for those learning to use their own voice.

WHEREAS, our highest respect goes to these children, as well as their families, for their effort, determination, and resilience in the face of such obstacles.

**NOW, THEREFORE**, We, The Bradford County Commissioners hereby proclaim May 14, 2024, as "Apraxia Awareness Day" in Bradford County and encourage citizens to work within their communities to increase awareness and understanding of Childhood Apraxia of Speech.

#### Bradford County Commissioners Office Resolution 2024-18

A Resolution of the Board of Bradford County Commissioners Supporting the Endless Mountains Heritage Region's Pursuit of a National Heritage Area Designation

WHEREAS, the Endless Mountains form a unique and diverse region in northeastern Pennsylvania and encompasses a patchwork of cultures and history, as well as spectacular natural, scenic and recreational resources that reflect a unique contribution to the collective American identity; and

WHEREAS, the Endless Mountains region is distinguished by rural pastoral landscapes shaped by centuries of agriculture and timbering, Native American lineage, and rolling hills overlooking the Susquehanna River North Branch that meanders through the 2,850 square mile region; and

WHEREAS, the United States Congress has the authority to designate National Heritage Areas that encompass a region where natural, cultural, historic, and recreational resources combine to form a cohesive, nationally distinctive landscape shaped by geography and cultural traditions; and

WHEREAS, the Endless Mountains National Heritage Area Feasibility Study was authorized by the PA Department of Conservation and Natural Resources (DCNR) and the Endless Mountains Heritage Region's (EMHR) board of directors,

WHEREAS, EMHR hired Point Heritage Development Consulting to evaluate the natural, historic, cultural, educational, and recreational resources and work with the EMHR to develop the feasibility study of the Endless Mountains; and

WHEREAS, the following counties are to be considered as part of the National Heritage Area feasibility study: Bradford, Sullivan, Susquehanna, and Wyoming; and

WHEREAS, Bradford County is within the Endless Mountains region and possesses a plethora of natural, cultural, historic, agricultural, and recreational resources pertinent to the feasibility study; and

WHEREAS, the Endless Mountains Heritage Region, founded in 1998, has worked tirelessly with the counties, various regional organizations, municipal governments, regional schools, and state agencies to preserve our cultural and historic assets and enhance outdoor recreational opportunities in the area, and has the desire and will act as the coordinating entity to pursue a National Heritage Area designation under the National Park Service.

NOW, THEREFORE BE IT RESOLVED THAT the Bradford County Board of Commissioners supports and agrees to participate in the feasibility study to designate a National Heritage Area for the Endless Mountains Heritage Region and strongly encourages all other Endless Mountains counties including Wyoming, Sullivan, and Susquehanna to engage in the feasibility study of the proposed Endless Mountains National Heritage Area.
