2024 Hunger Action Month Proclamation

WHEREAS, Hunger and food insecurity are issues of vital concern in Pennsylvania where, according to Feeding America, over 1.5 million individuals, one in eight Pennsylvanians, and one in every six children experience food insecurity. In Bradford County one in eight neighbors and one in six children are food insecure; and

WHEREAS, Adequate nutritious food has become more expensive and out-ofreach for many neighbors with food costs increasing more than 27%, leading to record demand for charitable food; and

WHEREAS, Food insecurity, the condition of limited or uncertain access to adequate food, is associated with numerous adverse social and health outcomes and is a critical public health issue; and

WHEREAS, Bradford County is committed to taking steps to combat hunger in every corner of our communities, and to provide additional resources to those in need; and

WHEREAS, Bradford County is committed to working with the Central Pennsylvania Food Bank to educate people about the role and importance of food banks in addressing hunger and raising awareness of the need to devote more resources and attention to hunger issues; and

WHEREAS, The Central Pennsylvania Food Bank distributed over 68.5 million pounds of food in Fiscal Year 2024 to Pennsylvanians experiencing food insecurity. In Bradford County alone, over 2.1 million pounds of food were distributed; and

WHEREAS, Public and private entities, including policymakers, business leaders, community activists, farmers, concerned citizens, and hunger relief organizations, must collectively work to address food-insecurity within the Commonwealth; and

WHEREAS, The month of September has been designated nationwide as "Hunger Action Month" to raise awareness of the issue of hunger and mobilize our legislature and the public to help end hunger in America; therefore be it

NOW, **THERFORE**, WE, THE BRADFORD COUNTY COMMISSIONERS, do hereby recognize September 2024, as HUNGER ACTION MONTH in Bradford County, Pennsylvania, and I call this observance to the attention of our citizens.

WHEREAS, incarcerated individuals who participate in adult education programs are 43% less likely to recidivate than inmates who did not; and

WHEREAS, these programs offer low or no cost, high value opportunities which upgrade the skill set of our citizens; and

WHERAS, the Bradford Wyoming County Literacy Program celebrates Adult Education and Family Literacy Week as a proud participant in the national Educate & Elevate Campaign which helps our citizens learn about all of their Adult Education options to attain their professional and personal goals.

Proclamation Recognizing and Expressing Support for the 9/11 Day of Service and Remembrance

On September 11, 2001, the peace and security of our nation was shattered by terrorist attacks that killed many innocent people at the World Trade Center Towers in New York City, at the United States Pentagon, and in the pristine fields of Shanksville, Pennsylvania.

Although the terrorists' goal was to strike a powerful blow to the hearts of all Americans and tear at the fabric our nation, arising from the very ashes of that tragedy came a remarkable spirit of unity, compassion and determination that will never be forgotten, just as we will never forget those who were lost and injured on that day, and those who rose in service during the rescue and recovery effort and in defense of our nation both here at home and abroad.

Now, 23 years after the September 11, 2001 attacks on America, we hereby adopt the following Proclamation in tribute to those lost and injured on 9/11, and the many who gave of themselves in service to their communities and to this country in the aftermath of the attacks:

WHEREAS, people of all ages and walks of life, across America, and around the world, collectively witnessed an event of immense tragedy on September 11, 2001; and

WHEREAS, the events of that day instantly transformed nearly everyone's lives, some through personal loss, and many others through an unfamiliar sense of individual and national vulnerability; and

WHEREAS, an unprecedented, historic bonding of Americans arose from the collective shock, unifying the country in an outpouring of national spirit, pride, selflessness, generosity, courage and service; and

WHEREAS, many brave people heroically, tirelessly and courageously participated in an extraordinarily difficult and dangerous rescue and recovery effort, in some cases voluntarily putting their own well-being at risk; and

WHEREAS, the date of September 11 will never, and should never be just another day in the hearts and minds of all Americans and people around the world; and

WHEREAS, many people may wish to memorialize September 11 by engaging in, or making a plan to engage in personal and individual acts of community service, or other giving activities, as part of a solemn day of remembrance and tribute; and

WHEREAS, on March 19, 2009, the United States Congress passed bipartisan legislation authorizing the establishment of September 11 as a federally recognized National Day of Service and Remembrance, which President Barack Obama signed into law on April 21, 2009; and

WHEREAS, the President of the United States, on September 11, 2009, issued the Patriot Day Proclamation officially and permanently designating September 11 as a National Day of Service and Remembrance, and calling upon all interested Americans to participate in this observance through moments of silence, the flying of the flag of the United States at half-staff, as well as community service and charitable activities in tribute and remembrance; and

Now, therefore, BE IT RESOLVED, that in tribute to all of the victims of 9/11 and the many who rose in service in response to the 9/11 terrorist attacks, the Bradford County Commissioners recognize Wednesday, September 11, 2024 as a voluntary Day of Service and Remembrance. known as "9/11 Day," and call upon all Bradford County residents and organizations to consider joining in this important national observance by engaging in activities of remembrance and tribute, including memorial services, prayer, flying the American Flag as half-staff, and engaging in any form of charitable service, including volunteer, supporting charities, and performing other good deeds in the same spirit of unity, resilience and compassion that brought Americans together in the immediate aftermath of the 9/11 tragedy.
